Net Generation of Subsidiary Power Plants Increased by 7.4%,
among which Subsidiary Wind Farms Increased by 10.5%,
Photovoltaic Plants Increased by 141.5%**

Total net generation of subsidiary power plants in December 2024 increased by 0.9% year on year to 20,049,753 MWh, among which, subsidiary wind farms increased by 4.6% year on year to 4,134,954 MWh, subsidiary photovoltaic plants increased by 109.2% year on year to 608,776 MWh.

Total net generation of subsidiary power plants for 2024 increased by 7.4% year on year to 207,636,651 MWh, among which, subsidiary wind farms increased by 10.5% year on year to 43,770,723 MWh, subsidiary photovoltaic plants increased by 141.5% year on year to 6,916,074 MWh.
