Net Generation of Subsidiary Power Plants in the First Eleven Months of 2019 Decreased by 2.1%

China Resources Power Holdings Company Limited (“CR Power”, stock code: 0836) today announced that total net generation of subsidiary power plants in November 2019 increased by 16.3% to 13,094,347MWh from 11,256,670MWh for the same period of 2018. Total net generation of subsidiary power plants for the first eleven months of 2019 decreased by 2.1% to 133,859,956MWh compared to 136,686,503MWh for the same period last year. (Note: The above generation volume does not include the volume sold to independent third parties.)

On a same plant basis, total net generation of subsidiary coal-fired power plants for the first eleven months of 2019 decreased by 5.7% compared to the same period of 2018. Power plants located in Hubei recorded 12.2% increase year on year. Power plants located in Henan, Guangdong, Hebei, Jiangsu and Other provinces recorded 18.5%, 8.5%, 4.9%, 4.5% and 4.8% decreases year on year, respectively.
