## Net Generation of Subsidiary Power Plants of 2019 Decreased by 1.6%

China Resources Power Holdings Company Limited (“CR Power”, stock code: 0836) today announced that total net generation of subsidiary power plants in December 2019 increased by 2.3% to 15,326,130MWh from 14,983,606MWh for the same period of 2018. Total net generation of subsidiary power plants for the full year of 2019 decreased by 1.6% to 149,186,086MWh compared to 151,670,109MWh of 2018. (Note: The above generation volume does not include the volume sold to independent third parties.)

On a same plant basis, total net generation of subsidiary coal-fired power plants for the full year of 2019 decreased by 5.6% compared to 2018. Power plants located in Hubei recorded 10.5% increase year on year. Power plants located in Henan, Guangdong, Hebei, Jiangsu and Other provinces recorded 19.6%, 6.4%, 5.7%, 3.9% and 4.8% decreases year on year, respectively.
