Net Generation of Subsidiary Power Plants Increased by 14.4%,
among which Subsidiary Wind Farms Increased by 5.4%**

Total net generation of subsidiary power plants in December 2020 increased by 14.4% year on year to 17,539,073MWh, among which, subsidiary wind farms increased by 5.4% year on year to 1,933,174MWh.

Total net generation of subsidiary power plants for 2020 increased by 3.9% year on year to 154,944,171MWh, among which, subsidiary wind farms increased by 21.6% year on year to 20,232,193MWh.
