Net Generation of Subsidiary Power Plants Increased by 8.6%,
among which Subsidiary Wind Farms Increased by 33.6%**

Total net generation of subsidiary power plants in October 2020 increased by 8.6% year on year to 12,002,162MWh, among which, subsidiary wind farms increased by 33.6% year on year to 1,824,369MWh.

Total net generation of subsidiary power plants for the first ten months of 2020 increased by 1.9% year on year to 123,044,752MWh, among which, subsidiary wind farms increased by 25.3% year on year to 16,415,154MWh.
